2004 ACMA Winter Conference: "Enhancing the Personal Side of Our Profession"

The ACMA 2004 Winter Conference is February 4-6, 2004, at the Hilton Sedona Resort and Spa in Sedona. Room reservations at the group rate of \$110/night may be made by calling 928-284-4040. The group rate will be guaranteed until January 4, 2004. The conference registration fee for ACMA members is \$295. Registration materials for the conference were mailed to members earlier this month and may also be downloaded from the ACMA web site, www.azmanagement.org. One new feature in the conference registration material is the addition of the ICMA Practice Groups addressed by each session. ACMA Members who are participating in the ICMA Voluntary Credentialing program should find this information useful as they work to fulfill the 40 hours of professional development required to maintain credentialing.

The conference theme is "Enhancing the Personal Side of Our Profession." Conference sessions will focus on the human side of local government management. During the opening session, participants will have the opportunity to learn more about our Code of Ethics through the fun and interactive session "Who Wants to be an Ethical Millionaire?" hosted by Tucson City Manager, Jim Keene. One of the most unique aspects of being a local government manager is working through election cycles knowing that on election day the priorities and policy direction you have been given can completely change; Thursday morning, a panel of long tenured managers will offer insight into managing through an election year. The Thursday

afternoon session will focus on hiring practices and techniques you can utilize to improve your recruitment processes and save your organization the costs associated with hiring the wrong person for the job. The ICMA Voluntary Credentialing Program is gaining a lot of momentum and more and more ACMA members are participating. Are you a candidate for credentialing? Friday morning you will have the opportunity to learn what the credentialing process entails, who is eligible, and why you may want to consider participating in the program. The final education session will focus on manager evaluations that are effective and useful to both managers and the elected officials they serve.

Pre-Conference Workshop Offers Tools to Improve Communication

The ICMA University Workshop "Managing in a Fishbowl" is a new workshop presented by Jacqueline Reid with the Center for Interpersonal Excellence. The workshop will be offered Wednesday, February 4, as the pre-conference session. Recognizing that local government managers live and work in an environment of high visibility where every decision is scrutinized and every sentence is dissected, this workshop will provide participants with proactive tactics (preventing problems before they occur, diffusing strong emotions) and a fast-paced forum for capturing the expertise of your colleagues. **It is not necessary to register for the ACMA Winter Conference in order to register for this workshop, it may be a great opportunity for you and your staff to attend the workshop together.** The cost of the workshop is \$75, participants will receive ICMA University credit and ICMA University Workshop certificates.

City of Phoenix Taps into Andrews/Esser Scholarship Finalist

Last January I participated on the interview panel for the Andrews/Esser Scholarship. Without exception, the candidates were bright and deserving individuals. That made the decision especially difficult. Heidi Spann, MPA student at Arizona State University, stood out as an ideal intern for the Head Start program that I manage for the City of Phoenix.

Heidi's excellent interview, background with community organizations, Bachelor of Social Work degree and MPA coursework and training seemed an ideal fit for Head Start. I made a mental note that if she was not a scholarship winner, I would talk with her about possibly interning with Head Start. When we had an internship opportunity through funding from the City's Personnel Department, Heidi competed for the position.

Heidi was the successful candidate and has worked for our program since August 2003. She worked on a community assessment required for the renewal of our \$20 million Head Start grant. This involved surveying Head Start parents and community members on community needs.

Heidi refined the survey and created a database for tabulating the data. In addition, she completed an extensive demographic report and coordinated volunteers from ASU to staff focus groups. In the end, we had 1,900 surveys returned. After entering the data, Heidi produced reports for the 14 delegate agencies who operate classrooms on behalf of the City of Phoenix.

She also coordinated a special event for Head Start Awareness Month involving the State School Readiness Board, Valley of the Sun

United Way and Southwest Human Development. This summit on early childhood education brought together experts in the field to discuss ways for the City of Phoenix to support early care and education in the community. The event was a great success with almost 100 people in attendance.

We tried to get Heidi to spend a few more months with us, but she needed to concentrate on her last semester at ASU and her other job. She is not only a full-time student, but also has an assistantship/fellowship through the MPA program. We need to thank ACMA for enabling us to identify a wonderful intern who completed a tremendous amount of work for our Head Start program.

Proposals are currently being accepted to host the 2004 Andrews Intern. Cities and towns with populations of less than 50,000 and counties with populations of less than 100,000 may apply to host the internship. ACMA Members Meet with NAU President

In an effort to combat rapidly increasing enrollment rates and large cuts to university budgets the Arizona Board of Regents launched Changing Directions (August 2002) an initiative to reform the Arizona university system. Each university has been asked to reshape their programs to better meet the needs of Arizona's citizens and communities. As a result of these changes, educational options for students will become more diverse as institutional missions become more focused and universities collaborate further on academic program offerings.

As our universities begin to create their own unique identities and missions it is an opportune time to begin our discussions on how ACMA and our universities can develop partnerships and work more collaboratively. NAU outlines a number of goals in its Changing Directions paper that are compatible with ACMA goals and resources - so this was an ideal time to sit down and talk with President Haeger.

President Haeger was very interested in learning about ACMA and understood the mutual bene-

fits that could result from building partnerships and improving communication between our organizations. Conversation during the meeting focused on civic discourse and the importance of recognizing the unique needs of rural communities. President Haegar stated the mission of NAU is to serve rural Arizona and that he was not aware of any research taking place right now that was looking at rural Arizona. The idea of creating a rural policy institute at NAU was discussed as well as the re-establishment of an advisory committee for NAU's Master of Public Administration program.

In an effort to continue dialogue and improve communication with our state universities ACMA representatives will also be meeting with Arizona State University and University of Arizona administration.

ACMA Ethics Column- Ask the Expert

Buying a Home in a Competitive Market

Scenario: The county manager has agreed to buy a house from an individual who works for a law firm in the community, a firm that does work for developers and appears before the county when plans are reviewed. Because the housing market is booming in this community, homes sell quickly. This particular house was never listed for sale, and the county manager learned about it from a friend. The manager wanted to know if the purchase of the house raised any conflicts of interest. She also asked for feedback on the idea of a third party's holding the mortgage on the home.

Response: To minimize the possibility of any ethical or political problems with the purchase of this home, the county manager should disclose the pending sale to the elected officials. Although the seller has contact with the county, the manager understands that the individual selling the house has no direct interest in any development plans in the community. Under these circumstances, there seems to be little threat of a conflict of interest.

The proposed third-party loan raises more ethical concerns. Such arrangements are more likely to create either an appearance of a conflict of interest or an actual conflict of interest. The risk of an ethical conflict is strong when the person holding the mortgage is a county resident working for an organization that does business with the county.
